The Supervisor, Ronald Moore, opened the Special Board Meeting at 6:30 PM.

Present with the Supervisor were Board Members Laureen DeZalia, Marshall Gero, Jean Gokey and Donald Dresser. The Town Clerk, Sarah Vinskus, was also present.

The Supervisor then went over North Hudson Town Law #1 which pertains to unsafe buildings and structures.

A report in writing to the Town Board outlining the findings and recommendations in regard to removal or repair shall be prepared by the Codes Enforcement Officer.

If the Board finds such building(s) dangerous and unsafe to the public, it shall be resolution order its repair or demolition and removal, and shall further order a public hearing be held before the Town Board.

The notice shall contain a description of the premises; a statement of particulars; an outline of how it is to be made safe or demolished and removed; a statement that repair or demolition and removal shall commence in thirty days, completed in sixty days. An extension may be allowed for up to thirty days. A date and time and place for a hearing, no less than seven days nor more than fourteen days from the date of the Service of Notice.

The notice shall be served by personal service, within the Town, of a copy thereof, or by mailing; and by personal service to any adult residing in said premises.

A copy of these notices as provided herein shall be filed in the Office of the Clerk of the County of Essex.

The owner or authorized representative may appear before the Town Board. Following the hearing, the Town Board shall give notice to the owner of the Board's determination. The Board may determine that the original order shall remain in full force or effect, or it may amend said order, or it may rescind said order.

The Town Board may make such repairs as necessary, or demolish and remove the structure and may cause all costs and expenses to be assessed against the land on which the buildings were located.

The penalties for failure to comply for the first week's continued violation, will be not less than \$100 nor more than \$250, or to imprisonment for no more than 15 days, or both.

All expenses incurred by the Town shall be assessed against the land on which the building or structure is located.

Therefore the following resolutions are according to each individual property owner.
