## TOWN OF NORTH HUDSON REGULAR TOWN BOARD MEETING THURSDAY, SEPTEMBER 11, 2014

The Meeting was opened at 6:30 PM by the Supervisor, Ronald Moore, who led the assembly in the Salute to the Flag.

Present with the Supervisor were Board Members Laureen Dezalia, Marshall Gero, Robert Dobie and Donald Dresser. Sarah Vinskus, the Town Clerk, was also present.

Guests present were Angela and Tiffany Nolan and Philip and Grace Merlino.

The Clerk read the Minutes of the August 14<sup>th</sup> Board Meeting.

Donald Dresser moved and was seconded by Laureen DeZalia to accept the Minutes as amended. All voted "Aye".

The Supervisor then went over the contents of the Board Members' packets.

The Supervisor's Financial Report as of August 31, 2014 is as follows:

The Special Election will be held on September 18<sup>th</sup> and absentee ballots are not permitted.

The five Towns visited the Otter Creek horseback riding facility with members of the Grafton Horse Trail Riders on August 20<sup>th</sup> to see the facility and get ideas of how they might apply to the equestrian network we will be building. Plans are to visit each town's sites where they plan on building their facilities.

The County BOS passed an amendment in regard to our woodlot, tax map #125.1-1-30.100. Instead of paying the full amount of \$11, 248.12 to the county, we will pay \$10,169.53 to the County and be responsible for the 2014-2015 school tax. The result is the same amount of money.

The Highway Department has had Moriah Shock in a few times assisting with our winter wood prep. Also some of the wood cut has been marketed, thus helping revenues. We have been delivering sand for a FEMA buyout of the James McNaughton residence. The paving on Wonderview will begin when the County finishes with Johnson Pond. Then we will rent their excavator. The Highway Superintendent would like to either scrap or put out for bid the loader and the 2003 pickup. Mr. Moore put in a request into Earth Metal & Waste to see if they would be interested and what prices would be. We would have to replace two batteries in the loader and they are estimated to cost \$200 each. Bruce Caza has requested to exchange 1000 yards of sand from his mine for 1000 yards from ours.

The County Board of Supervisors are reviewing options for the solid waste bid.

Sarah Potter, our Dog Control Officer, is taking a leave of absence due to a medical issue. Laurie Bruce of Schroon Lake is willing to help. Mr. Moore thinks the town should seek a substitute Dog Control Officer and offer \$25.00 per call plus mileage.

This is an initiative from Jim McKenna and ROOST and the 5 Towns where we inventory material, such as attractions, businesses and so on in each town. On October 24<sup>th</sup> from 10 AM to 3 PM there will be a follow-up meeting in Lake Placid with all 5 Towns present. They would like 3-5 members from each town present.
