TOWN OF NORTH HUDSON REGULAR TOWN BOARD MEETING THURSDAY, AUGUST 14, 2014

The Supervisor opened the Meeting at 6:30 PM and led the assembly in the Salute to the Flag.

Present with the Supervisor were Board Members Laureen DeZalia, Marshall Gero, Robert Dobie and Donald Dresser. The Town Clerk, Sarah Vinskus, was also present.

Guests present were Rod Boula (CEO and Administrator of Elizabethtown Hospital), TJ Garcia, Joseph Provoncha, Brian Caza, Sindy Brazee, Angela and Tiffany Nolan, Will Plumstead and William Pekurney.

Mr. Boula spoke first about the improvements made to the hospital in terms of physical improvements in patient care. He said that Fletcher Allen Hospital in Vermont and Elizabethtown Hospital are now partners but the biggest hold back to realizing full benefits of this union is NYS and Vermont do not recognize each other's licenses. He then answered questions.

The Town Clerk read the Minutes of July10, 2014.

There is a change in County auction terms and conditions to be made stating that an individual cannot bid on properties if he/she has unpaid taxes on already owned property. Soil and Water Manager Dave Reckahn who said that he had hired an intern and asked if we would be interested in him looking at our lands. Mr. Moore said yes, especially land on the other side of the Schroon River. The estimated cost is to be in the \$400 to \$500 range.

Mr. Moore on Monday, August 4th, signed the forms transferring what has been referred to as the woodlot, parcel 125.1-1.30.100 from Essex County to the Town of North Hudson in consideration of \$11,248.12.

Resolved that the Town Clerk, Sarah Vinskus, is hereby authorized to expend the amount of \$880.00 for the preservation of Minutes Book 1940 – 1949.

Mr. Moore spoke to Tish Biesemeyer in regard to health insurance and she expects medical insurance to increase this year possibly by double digits. He also asked about the cost of dental insurance, which she will investigate.

The 5 Towns – Minerva, Newcomb, North Hudson, Indian Lake and Long Lake – expect to receive \$50,000 each as part of a total of \$250,000 state funding for an Equestrian Network. There is a trip scheduled to go to Otter Creek, where there is a DEC facility specifically built for horseback riding. The trip is scheduled for August 20th and some trail riders are going along.

There is second grant application that has been submitted for the 5 Towns in the amount of \$500,000 and if it is granted it could provide another \$60,000 for each town.

Mr. Moore received an email from Todd Smith who identified himself as the coorganizer of the Hobofest music festival held in Saranac Lake. He wanted to come and discuss a possible future use of Frontier Town if we acquire it.

The Schroon Lake Senior Citizens will be holding a picnic at the beach on Friday, August 22nd. They usually set up at 10:30 AM and serve between 11:00 AM and 11:30 AM. The menu consists of BBQ ribs, potato salad, coleslaw, rolls and dessert.

Mr. Moore has sent out budget requests to all department heads. He hopes to have a tentative budget ready for the Board shortly after the special election.

The Schroon Lake Ambulance may lose their ALS certification as soon as October. They may have to go to paid personnel. They are recommending two paid people, one ALS Certified, and the other as a driver. The quote for those two for 12 hours a day, 7 days a week is

approximately\$110,000 for the ALS Tech and \$85,000 for the driver, which is about \$200,000. Their normal operating funds have been about \$45,000 from Schroon Lake and \$11,250 from North Hudson.

The Grafton Horse Trail Riders have scheduled a weekend ride here in North Hudson on October 4th through October 6th. The Fire Department is scheduling a chicken barbecue during the same period. Thanks to the Fire Department for putting this on for us.
