B. County Reports-

- **1.-** Chairman Gilliland, Jim Dougan, Supervisor DeZalia and Community resources have met and hired a firm to do the project proposal, plan and drawings for the proposed project on the County owned Frontier Town Property.
- **2.-** Chairman Gilliland reported to the Board of Supervisors that all the glass recyclables from all of the Essex County transfer stations have been dumped by Sirkil at a sand pit for many years. The County attorney is going to write Sirkil to find out why as all believed it was being recycled. The landowner once had a contract for crushed glass to mix with sand but that had run out. This is not crushed glass being dumped but is glass recyclables mixed with cans etc being dumped. Supervisor DeZalia stated this is not acceptable and the County will get to the bottom of it. She indicated that now that this has been made public the DEC will be involved.
- **3.-** CSEA negotiations have been completed and negotiations with the Sherrifs Department are taking place.
- **4.**-The County is looking at a County supported daycare for County employees.

Resolution # 101 of 2021

Resolved to adopt proposed Local Law #1 of 2021 entitled A Local Law to Override the Tax Levy Limit Established in General Municipal Law §3-c

LOCAL LAW NO. #1 of 2021

"A Local Law to Override the Tax Levy Limit for Fiscal Year 2022" Be it enacted by the Town Board of the Town of North Hudson as follows:

SECTION 1. AUTHORITY. This Local Law is enacted pursuant to subdivision 5 of N.Y. General Municipal Law §3-c (the "Property Tax Cap Law"), which expressly

authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board.

SECTION 2. PURPOSE. The purpose of this local law is to permit the Town Board to override the tax levy limit on the amount of property taxes that may be levied by the Town of North Hudson pursuant to the Property Tax Cap Law, and to allow the Town to adopt a budget for Fiscal Year 2022 that requires a real property tax levy in excess of the "tax levy limit" as defined by the Property Tax Cap Law. Such override is necessary and in the best interests of the Town.

SECTION 3. TAX LEVY LIMIT OVERRIDE. The Town of North Hudson Town Board is hereby authorized to override the Tax Levy Limit established pursuant to N.Y. General Municipal Law §3-c, for Fiscal Year 2022, and to adopt a budget for Fiscal Year 2022 that requires a real property tax levy in excess of the amount otherwise prescribed in N.Y. General Municipal Law §3-c.

SECTION 4. SEVERABILITY. If any clause, sentence, paragraph, section or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to said clause, sentence, paragraph, section or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such order or judgment shall be rendered.

SECTION 5. EFFECTIVE DATE. This local law shall take effect immediately upon its filing with the Secretary of State as provided in §27 of the N.Y. Municipal Home Rule Moved by Councilan Dobie Second by Councilwoman Marsden
