5. Old Business

A. Main Street Revitalization Program update

Prior to this meeting we had a well-attended informational meeting at 5 pm. Anna Reynolds presented a summary of the entire process, the application process, check list page, the instructions and the scoring page. Anna answered numerous questions from those in attendance. A few residents have already picked up applications.

Supervisor DeZalia read Matt Simpsons opening statements from the Forward Together conference.

B. Frontier Town Notice of intent-SEQR

SEQR (State Environmental Quality Review)

Supervisor DeZalia explained the County is the lead agency on the Restore NY Grant and the restoration and cleanup of various buildings in Frontier Town.

C. Quality Affordable Workforce Housing Update

The County will have a meeting on October 30th at 11am for the discussion of the sale of property to Mr. Kavanaugh.

Resolution# 63 of 2023, a resolution of support of being a pro housing community, was read by Supervisor DeZalia. She added that this gives North Hudson an advantage when applying for future NYS grants meeting the bonus points for future projects.

D. LED Street Lighting

Supervisor DeZalia received prices to convert the street lights to LED lights. She explained that the conversion cost would be \$1,699.48, plus National Grid is offering a \$3,000 incentive to do this.

Resolution #66 of 2023

Resolution to proceed with the conversion of the streetlights to LED energy efficient lighting with the proposed incentives by National Grid.

E. Broadband

Supervisor DeZalia explained that she has 2 zoom calls every month regarding broadband with SLIC, Verizon, Hudson Valley wireless, members of the Assembly, Congress and others. Discussion on Connect All in Franklin County to come up with different ways to get broadband to everyone. She added the difficulties that installers are having.

Supervisor addressed the letter she and the board members received from a Duntley Road resident asking what happened to the grant money North Hudson was provided. She clarified this by stating" the Town of North Hudson never has had a grant for broadband."

Kevin Lynch provided Supervisor DeZalia a map of the original coverage area awarded to SLIC by the Connect NY program. In 2016 SLIC provided coverage to just north of Ensign Pond Rd, funded by the Connect NY program. In 2017 SLIC built out to Pepper Hollow Rd. This was funded privately by the cell tower provider and SLIC extended services to homes passed along the way. Later in 2017, SLIC was awarded phase 3 funding which they did not realize for several years later to include Greenough Road. It was noted by Supervisor DeZalia that she and the Board will make sure North Hudson stays on the map and will continue to work diligently to obtain broadband service for those areas in our community currently without service.

Kevin Lynch from SLIC is hoping the BEAD funding for broadband will address these issues but it is at least 12 months away.

a. Local Law to Override Tax Cap

Resolution # 67 of 2023

The following resolution was offered by Supervisor DeZalia, who moved for its adoption. Upon the passage of a motion to consider from the floor, and the same appearing proper and necessary.

Be it Resolved that the Town of North Hudson Town Board hereby introduces proposed Local Law # 1 of 2023 entitled "A Local Law to Override the Tax Levy Limit Established in General Municipal Law § -3c "reading and provided as follows:

"A Local Law to Override the Tax Levy Limit for Fiscal Year 2024"

Be it enacted by the Town Board of the Town of North Hudson as follows:

SECTION 1. AUTHORITY.

This Local Law is enacted pursuant to subdivision 5 of N.Y. General Municipal Law §3-c (the "Property Tax Cap Law"), which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board.

SECTION 2. PURPOSE.

The purpose of this local law is to permit the Town Board to override the tax levy limit on the amount of property taxes that may be levied by the Town of North Hudson pursuant to the Property Tax Cap Law, and to allow the Town to adopt a budget for Fiscal Year 2024 that requires a real property tax levy in excess of the "tax levy limit" as defined by the Property Tax Cap Law. Such override is necessary and in the best interests of the Town.

SECTION 3. TAX LEVY LIMIT OVERRIDE.

The Town of Clinton Town Board is hereby authorized to override the Tax Levy Limit established pursuant to N.Y. General Municipal Law §3-c, for Fiscal Year 2024, and to adopt a budget for Fiscal Year 2024 that requires a real property tax levy in excess of the amount otherwise prescribed in N.Y. General Municipal Law §3-c.

SECTION 4. SEVERABILITY.

If any clause, sentence, paragraph, section or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to said clause, sentence, paragraph, section or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such order or judgment shall be rendered.

SECTION 5. EFFECTIVE DATE

This local law shall take effect immediately upon its filing with the Secretary of State as provided in §27 of the N.Y. Municipal Home Rule.

Be It Further Resolved that the Town Board of the Town of North Hudson the 8th day of November 2023 at 5:30 p.m. in the forenoon of that day, to hear any and all persons concerning the same; and

Be It Further Resolved that the Clerk of the Town of North Hudson will publish notice of such hearing is designated Town newspaper at least five days prior to said hearing in the Town newspaper at least five days prior to said hearing.
