a. - Budget overview-

On November 8th at 5:30 the Town Board held the Public Hearing for the proposed Local Law # 1 of 2023, A Local Law to Override the Tax Cap Levy and then at 6:00 pm a Public Hearing was held for the 2024 Preliminary Budget.

Only one guest was present.

Supervisor DeZalia explained the Tax Cap allowed by NYS was 2% and it was very difficult to keep it close to the tax cap and keep taxes relatively the same this year. This included giving employees 3% raises, no increases to elected officials and an increase of 12.5% increase in health insurance. Supervisor DeZalia stated" We have chosen to return to the taxpayers \$448,870 of Fund Balance to help keep the Tax Levy stable this year, this is something we have done every year since I have been in office. The Fund Balance is what is left over and unallocated at the end of each year. If the Town is careful

with its spending and follows procurement to get the best prices and budgets carefully, there should be the ability to do this annually. It is important, to also keep an appropriate fund balance available in each of the General and Highway accounts to cover any unforeseen emergency or disaster recovery. It's a balancing act and I believe the Board and I have presented a good Budget that is fair and fiscally responsible."

b.- Local Law#1 of 2023 Resolution adopting proposed Local Law to Override tax levy

Resolution #71 of 2023

LOCAL LAW NO. #1 of 2023

"A Local Law to Override the Tax Levy Limit for Fiscal Year 2024"
Be it enacted by the Town Board of the Town of North Hudson as follows:
SECTION 1. AUTHORITY. This Local Law is enacted pursuant to subdivision 5 of N.Y. General Municipal Law §3-c (the "Property Tax Cap Law"), which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board.

SECTION 2. PURPOSE. The purpose of this local law is to permit the Town Board to override the tax levy limit on the amount of property taxes that may be levied by the Town of North Hudson pursuant to the Property Tax Cap Law, and to allow the Town to adopt a budget for Fiscal Year 2024 that requires a real property tax levy in excess of the "tax levy limit" as defined by the Property Tax Cap Law. Such override is necessary and in the best interests of the Town.

SECTION 3. TAX LEVY LIMIT OVERRIDE. The Town of North Hudson Town Board is hereby authorized to override the Tax Levy Limit established pursuant to N.Y. General Municipal Law §3-c, for Fiscal Year 2024, and to adopt a budget for Fiscal Year 2024 that requires a real property tax levy in excess of the amount otherwise prescribed in N.Y. General Municipal Law §3-c.

SECTION 4. SEVERABILITY. If any clause, sentence, paragraph, section or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to said clause, sentence, paragraph, section or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such order or judgment shall be rendered.

SECTION 5. EFFECTIVE DATE. This local law shall take effect immediately upon its filing with the Secretary of State as provided in §27 of the N.Y. Municipal Home Rule
