Essex County Soil & Water has suggested that we purchase compliant sand on the County Contract to lessen the amount of salt needed. Supervisor Clark explained that the cost of purchasing sand compared to what the Town has been using would be covered with the lack of salt the Town would need to purchase. He stated North Hudson uses more salt than many towns that have many more roads because of the poor quality of our sand. By purchasing better quality sand the Town will save money, have better roads and be safer as the men would not have to climb up and break chunks up along the roads. He stated it would the save the Town money and make the roads safer.
